

Annual Report 2022 - Chief Scout



2022 was a year full of ups and downs for the Association.

In the wake of COVID, the Association was faced with a surging demand fornew members, but our ability to take on new members was limited by our ability to meet the demand. This prompted several initiatives to strengthen our organisation.

One area of focus was the governance of the organisation. In 2022, four new members joined the NSC. They've brought new ideas and perspective to the organisation.

The National Scout Council also chose new members for the Finance Audit andRisk (FAR) Committee. This team supported the NSC with matters related tofinancial audits and risks. We also added a new director to TSAM to represent the NSC and a new representative for the Awards Committee.

We completed a GSAT self-assessment as a joint project between the NSC and the Executive. Different teams looked at the governance and processesin different parts of our organisation and concluded with a final workshop. The result is a blueprint we will use to identify those areas which need more work and help us identify the best practices recommended by WOSM.

The delays in securing permits for the renovation at IHQ made it hard for our national teams to work efficiently without a steady home base. We're working hard to fix this.

Since the National Scout Youth Council stopped working, we started discussing how to keep young people involved in all levels of the organisation. We areaware that WOSM intends to roll out new guidelines on this topic shortly, and the plan is to align our new strategy with these new guidelines.

In 2022, the Association lost several hard working and dedicated members who have 'gone home'. One member in particular was Anthony Rizzo, theformer chairman of TSAM Limited. He did a lot of work for our cause, especiallywith the Ghajn Tuffieha car-park project. His hard work and love for scoutingwon't be forgotten and will have an impact on our organisation for years to come.

Throughout the year, we helped different groups with advice on things like property, banking, leadership, and safety. We did this to make sure our groups are run well and responsibly.

Finally, we decided to hire a full-time Admin Manager. The objective is to have a volunteer-led organisation which is backed by professional staff whoprovide stability and continuity to the organisation.

With all the ups and downs that come with the running of a large organisationlike ours, we are proud that our Association continues to offer a quality non-formal education to young people, in a safe and healthy environment. Thankyou for playing your part in this team effort.



Adult Resources and Training Department



The year 2022 was a busy but a very fruitful year for the Adult Resources and Training Department.

Woodbadge training courses continued to be well received and attended bymany members. Also, a number of food handling and first aid courses wereheld during the year. More courses were delivered by our own members instead of engaging external speakers. This enhanced the delivery such that it is more relevant to our members since

the speakers could relate more to their own scouting experience.

The team also increased with two new members helping within the team, namely, Kimberley Vella and Maria Catania. Adding human resources helped in the ability of the team to provide more training opportunities for the 2023 pipeline.

At the end of the year Awards ceremony we had we had 28 that successfully completed their Pathfinder training, 36 who completed their Basic training, and 37 that completed their Advanced training.

Moreover, there were 84 members that started their training journey withthe Getting Started course. The Getting Started Course is the only modulethat was delivered online whereas all other courses have now started beingdelivered on a face-to-face basis.

The objective for 2023 is to provided skills courses in varying disciplines apart from implementing the Safe from Harm policy and the relevant training to raise more awareness within our groups.

Having more human resources in the team will enable the Adult Resources team to continue to support our members with their training and developmentas well as to offer different training opportunities that are relevant and needed within our groups.

The 8th European Scout Symposium happened in Kandersteg between the 18th and the 20th of March.

During this weekend, international commissioners, Chief Commissioners and key decision-makers in Scouting came together to represent their countries and share ideas. The main focus of this symposium was to discuss the Rotterdam's European Scout Conference which scheduled between the 22nd and the 26th of July. This was the first international meeting for many, since the pandemic, which made this event even more special.





European Scout Conference

The 24th European Scout Conference served as General Assembly of the members of the European Scout Region. Participants discussed a variety of matters relevant to the Region and elected the volunteer members of the European Scout Committee. Because of the strong relations and joint cooperation between the two European Regions of WAGGGS and WOSM, delegates and observers meet at joint sessions with delegations from WAGGGS during the European Scout and Guide Conference. It was at this Joint Conference that matters of mutual interest were discussed and plans for future joint work and joint events were approved.

Exchange Visit to Poland organised by the International Department

As part of its cultural diplomacy initiatives, the Embassy of Malta in Warsaw, for the first time ever, organised an exchange visit to Poland for a group of 12 Maltese Ventures and Rovers from the The Scout Association of Malta. The aim of this youth exchange was to foster people-to people contacts, sharing of Maltese culture and building tasks together for better understanding towards bringing solidarity, empathy, and peace among different nationalities.

The visit was co-ordinated with the Polish Scouting and Guiding Association. The Maltese scouts joined the Rover Jamboree on the eastern region of Poland in Podlasie, an unspoiled nature province. The main theme was Wędrownicza Watra (Spark from Podlasie). The participants organized their own activities, to discover the beauty of untouched nature, understand the culture and do good to the environment. The Maltese contingent presented typical Maltese food and performed traditional Maltese games.



In Warsaw, the Maltese scouts visited the Embassy and shared their experiences with the Ambassador of Malta, H.E. Marisa Farrugia. To mark theimportant role of the Polish scouts, the Maltese group, together with Polish Scouts, placed a wreath at the monument of the



Polish young insurgent, Pomnik Małego Powstańca, Podwale, which represents the Polish scout youths who lost their lives in defence of their homeland as humanitarian aid volunteers during the Warsaw uprising (August-October 1944).



The Academy 23

This year's edition of the Academy was carried out virtually between the 30th of October and the 7th of November. The event was open to anyone holding a role at national level in a WAGGGS or WOSM. The staff members and volunteers, ranging from members of working groups up to Chief Commissioners come from all over the world. Our association fully participated in most of the events held throughout the week. The Academy isa unique Scout and Guide event designed to enable participants to get high quality training and networking opportunities around the core priorities of the European Regions of WAGGGS and WOSM.

Numerous groups participated in this year's edition of the JOTA JOTI organised by WOSM between the 14th and the 16th of October. This is the world's largest digital Scout event that takes place on the Internet and over the airwavesand connects millions of young people around the



world for a full weekend of online activities that promote friendship and global citizenship. JOTA-JOTI enables young people and volunteers to participate in fun and engaging group activities over the Internet and amateur radio focused ondeveloping 21st century skills through Scouting.

Sustainability Forum

The 1st edition of the European Sustainability Forum, as part of the work initiated during the Triennium 2019-2022 happened between the 20th and the 23rd of October 2022. The aims of this forum were to gather representatives from NSOs and NSAs who are working or deeply



interested in Sustainability and the SDGs. During the weekendparticipants shared the knowledge to build the next steps on the work of the Region andits NSOs towards more sustainable operation. Mike Borg, our representative in the forum, is currently working to set up a policy for the localNSO on sustainability.

Academy 22

This year's edition of the Academy was held in Vilnius Lithuania between the2nd and the 6th of November. Our representatives were Kimberly Vella (from the Training department) and Vincent Micallef (from the Scout Council). Theacademy is a unique Scout and Guide event designed to enable participants to get high quality training and networking opportunities around the core priorities of the European Regions of WAGGGS and WOSM.

National Events Report 2022



2022 offered optimism as we started returning to normality following the COVID-19 pandemic. However, measures and restrictions were not yet fully clear, especially for mass gatherings and consequently, planning a national event required a certain level of caution. Due to this degree of uncertainty, planning well in advance was not possible.

Responsibly following all guidelines in place, the Association organised the following events:

On Sunday 20th March 2022, Ventures, Rovers and Leaders participated in the first physical national event after a 2 year-long break due to the pandemic. The national trail consisted of a circular 10 km trek around Rdum il-Qammieh: passing through astonishing surroundings: including Ghar Tuta and Ta' Oassisu window.

On Sunday 24th April, the yearly commemoration of Scouting and Guiding took place at Valletta. The Annual Rally started off with a mass at the Catholic Institute and the parade followed passing through the streets of our capital city, where the President of Malta was also present to receive the salute. The Seminary Scout Group, participated in the Annual Rally for the first time since the re-opening of the group.


On Thursday 30th June, we fired up the grill and organised a national gettogether open for all leaders and national staff. This BBQ event was held at the Mosta Scout Campsite.

Finance Commissioner - Annual Report 2022



A summary of the financial results is included in the Annual Report so I will not report on the actual accounts for 2022.

This year has been a year of change. A New Finance Commissioner, New Accountants, new fully computerised accounting system, a new fixed asset register for IHQ and for the groups, the first time they have been subject to an external audit.

It has been a struggle to cope with all these "news", especially for all of us who do the work, however with the assistance of Kimberly and Steve, the goodwill of all the sections and with the collaboration of the vast majority of the scout groups we got there. We had the financials ready by the end of May and the draft financial statements delivered to the auditors by the end of June. We also finalised the audit in time to meet the statutory deadline this year.

Are we happy with what we have achieved so far? No, not yet. This year we only just made the statutory deadlines and the auditors encountered severe difficulties in carrying out their work. Our aim for the coming year should be to try and organise ourselves better, reduce timelines and hopefully streamline accounting systems across the groups. IHQ is already set up to present its accounts by the end of February. The Groups deadline for the 2022 accounts was end of March, I think with a little more effort this can be shortened by a couple of weeks. However even end of March should be workable, as long as this deadline is strictly adhered to by all groups. Less than half the groups presented signed financial reports by that date.

Our office is here to help and not just impose deadlines, and although I am being replaced after this Assembly, my commitment to the individual groups remains, same. You all have my contact number and I will assist when requested.

Last but not least, BANKS, Administration and many groups have had problems with the banks this year. I apologise for not being able to handle all the queries and assistance that came my way.

13 Ce We spent the first half of 2023 trying to get the banks to accept the new signatories of IHQ. Things look brighter for this coming year.

We now have a new member on board and with her admin ability, is already well on her way to establish a solid database of all bank accounts held by the scouts and has established communication lines directly with the banks.

This will help us tremendously in satisfactorily tackling the constant requests you are receiving from the banks.

I would like to thank you all for the assistance and friendship you have extended to me over the last fifteen months I was in office.

The Malta Scout Fellowship, as many other organisations, after weathering the storm of the Covid pandemic at the start of 2022 started to considerwhat activities could be organized for its' members.

As our members are mostly senior citizens the holding of physical activities where kept on hold for the first few months.

The first activity held was on Sunday 24th April, a number of members of the Fellowship kept their yearly appointment and took part in the Annual Scout and Guides Parade.

The Fellowship Annual General meeting was held on Thursday 5th May 2022 at the Hamrun Scout Group Hall, Hamrun. During the meeting the Chief Commissioner Mr. Anton Pisani and the Fellowship Chairman Mr. Vincent Cassar were each presented with a book written by Mr. Giovanni Battista Stagno', St. Andrews Sea Scout Group Marsaxlokk 1944 – 1954'. The meeting was followed by a reception for all those present.

A Christmas Lunch was organised at the Conifor Hotel on the 11th December which was well attended.

The Executive committee continued to hold its' meetings on a regular basis in order to deal with the on-going business of the Fellowship. The main focus during the meetings was the future organisational status of the Fellowship remained a major topic. A meeting with The Chief Scout, and Chief Commissioner was also held in an effort to reach an agreement on the way forward. The discussion at these meetings mainly centered around the Fellowship Units in the Scout Groups and the uniform to be worn by members of the Fellowship.

Currently the Malta Scout Fellowship has thirty-six (36) members. Sadly, in December 2022 the Fellowship lost two (2) of our members, Mr. Joseph Micallef and Ms. Rose Laporto at the venerable age of 100 who was one of our last two remaining founder members of the Fellowship, besides Mr. Vincent Cassar.

Most notably for TSAM Limited, 2022 was the first full year after pandemic restrictions were lifted - meaning that Ghajn Tuffieha campsite returned to normal and consistent occupancy throughout the year. This was good news forcampers and returning customers! It was fantastic to see the campsite beingused to its full potential again and without the restrictions and regulations that were in place throughout the preceding two years. Everyone was happyto be back to camping!

Since we had dedicated a lot of resources and efforts to maintenance and improvement activities at the campsite during the slower periods of the pandemic, the campsite was looking better than ever.

It was decided during late 2021 to revise the camping fees for external customers (non-Scouts), the first time in many years, and we took the opportunity to standardise thepricing scheme - switching from a "per day" to a "per night" and assigning different prices depending on the size of the plot allocated.

The revenue streams of TSAM Limited were also diversified thanks to the opening of the car park at Ghajn Tuffieha which started slowly towards the end of 2021 and continued with consistent business until today. The proceeds from the parking fees go towards the operations cost of TSAM Limited and ultimatelythe Scout Association.

The planning and application process for IHQ hit a snag when designs werenot approved by the Superintendent for Cultural Heritage, even when these were modified as suggest by the Superintendent staff themselves. A meetingwith the Superintendent staff is being organised to be able to prepare and submit plans and designs that are acceptable and would be approved. The Floriana car park continued to operate and generate a modest amount of revenue.

Discharge of Responsibilities

External Audit

The FAR Committee has discussed on a number of occasions the Association's corporate governance and more precisely the way the Association handles their financial obligations. The Committee is aware of the complexity of the Association's structure which has an impact on the financial procedures it as to manage. The Committee would like to express that it is concerned that NSC and the Executive were not giving the due importance and requiredlevel of priority to addressing areas of attention in the financial reporting responsibilities of the association. The FAR Committee is of the opinion that the NSC and Executive must give a much higher level of attention to the Association's financial reporting process.

Global Support Assessment Tool (GSAT)

From the onset of its term-of-office (March 2021), the FAR Committee has strongly recommended to the NSC that a GSAT self-assessment take place inorder to assess current status of the Association. After months of insistencethe NSC (26th May 2022) approved the implementation of a self-assessmentwhich was completed on the 17th November 2022. The assessment identified a number of areas that require attention. Whilst the committee has been informed that there has been a revision to GSAT issued by WOSM, it is of the opinion that the self-assessment process that was started should be completed.

Strategy

The FAR Committee brought to the attention of the NSC that the SAM cannotoperate effectively without a clearly defined strategy and should therefore take the necessary action to address the matter. The Committee is pleased that after its insistence, in March 2022 the NSC appointed a small team to oversee the creation of a new strategy for the organisation. After a number of working sessions, the team took the view that the next most logical step was for the SAM to undergo a GSAT self-assessment and then use the results obtained to complete the process of creating a new strategy. It was the understanding of the FAR Committee that the strategic planning process would resume once the GSAT self-assessment was completed. This has nottaken place yet due to other more pressing priorities - the FAR Committee is of the opinion that this should be priority.
